SPANISH BROADCASTING SYSTEM, INC. RESCHEDULES THIRD QUARTER 2005 CONFERENCE CALL

- Third quarter call rescheduled to Tuesday, November $8^{\rm th}$ due to effects of Hurricane Wilma on the Company's corporate headquarters -
 - Miami radio stations fully operational during Hurricane period -

Coconut Grove, Florida – October 31, 2005 - Spanish Broadcasting System, Inc. (NASDAQ: SBSA) (the "Company") announced today that it has rescheduled the release of its third quarter 2005 financial results to Tuesday, November 8, 2005 due to the effects of Hurricane Wilma on the Company's Miami-based corporate headquarters. While the Company's corporate office is now operational, it had remained closed October 24-28, 2005 due to power and water outages that hampered the South Florida region. During that period, the Company's business operations continued to operate as usual, and its Miami radio stations operated at full power throughout the week under a normal broadcasting and advertising schedule.

The Company will now release third quarter 2005 financial results on Tuesday, November 8, 2005 prior to market hours, and host its quarterly conference call on November 8th at 2:00 p.m. Eastern Time.
